



Limited Power of Attorney

Be it acknowledged that I, _____ (Carrier/Carrier Company), the "Principal", do hereby grant a limited and specific power of attorney to Chrysalis Price Consulting, LLC as my "Attorney-in-Fact".

Chrysalis Price Consulting, LLC shall have full limited power and authority to undertake and perform only the following acts on my behalf:

This Limited Power of Attorney shall become effective immediately upon execution.

This limited power of attorney may be revoked by any of the following:

This Limited Power of Attorney shall remain in full force and effect until such time as it is revoked by the Principal in writing. The Principal reserves the right to revoke this authorization at any time, for any reason, by providing written notice to the Attorney-in-Fact and any third parties relying on this document. Revocation shall be effective upon receipt of such notice by the Attorney-in-Fact, unless a later date is specified therein.

This Limited Power of Attorney shall automatically terminate upon the Principal's death or legal incapacitation. However, any third party acting in good faith may rely on the authority granted herein until they have received actual notice of such revocation, termination, or the Principal's death or incapacity.
