Chrysalis Price Consulting, LLC shall bear no responsibility for the collections of freight charges or any revenue deemed
uncollectible from shippers, brokers, or third parties. **In the event that payment for a shipment or shipments is
delayed, disputed, or ultimately uncollectible, Chrysalis Price Consulting, LLC shall be held harmless and shall not be
subject to any penalty, deduction, or withholding of its fees.**

**Chrysalis Price Consulting, LLC shall be indemnified and held harmless from any and all claims, liabilities, losses, or
legal actions arising from or related to the transportation services provided by the Carrier/Trucking Company,
including but not limited to cargo claims, accidents, delays, or regulatory violations.**

**In any such event, the Carrier shall remain fully obligated to remit payment to Chrysalis Price Consulting, LLC for all
dispatch and consulting services rendered under this Agreement.**



The Service Fee for Chrysalis Price Consulting, LLC will be:

7 % per load

NOTE: This service fee covers not only day-to-day dispatching and logistics (e.g. spot loads), but also the additional service of securing long-term, dedicated shipping routes for the Carrier/Trucking Company.

As payment is received by the Carrier/Trucking Company for each successful delivery, a fee equal to the agreed-upon percentage shall become due and payable to Chrysalis Price Consulting, LLC.

Either party has the right to end this agreement without cause at any time with seven (7) day's notice by written or emailed request.
